There being no further matters before the Commission, the Commission adjourned at 11:19 a.m.

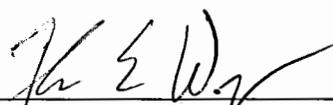

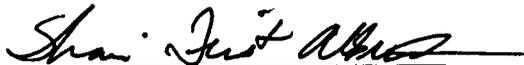
