MINUTES


1. The Commission convened the regular scheduled open meeting of the Commission at 10:00 a.m. on May 6, 2014 in the 3rd floor hearing room of the Kansas Corporation Commission, 1500 Arrowhead, Topeka, Kansas.
2. Present: Chair Albrecht, Commissioner Emler, and Commissioner Apple.
3. The following were considered by the Commission:


- c. **Other matters:**

There being no further matters before the Commission, the Commission adjourned at 10:49 a.m.




