
Commissioner Apple moved for approval of order #15-3637 - *Order on Petitions for Reconsideration* Commissioner Albrecht seconded.

The Commission moved into Executive Session at 10:10 a.m. and reconvened in public session at 10:30 a.m.


**The Commission took no action following this Executive Session.**


