Purpose:

To ensure that all employees who work at the Topeka office comply with the Emergency Operations Plan (EOP)

<u>Plan</u>:

All employees are responsible to follow the Commission's EOP and are required to participate both during drills and actual emergency alerts. The agency's designated Safety Officer is responsible for initiating an emergency response action to notifications of the emergency from the Capitol Police, National Weather Service, or other state, county or city authority.

Should an emergency notification from any of the above entities be received by an employee other than the Safety Officer, that employee shall immediately pass the notification on to the Safety Officer for initiation of emergency response action.

Safety personnel, including the Safety Officer, Floor Captains, Trained Responders and Section Supervisors are identified on **Exhibit A**.

Questions about the EOP should be directed to the Safety Officer or a Floor Captain.

Human Resources staff will ensure each employee receives a copy of the EOP and the Injury Accident Report policies during new employee orientation.

Post-EOP Directives:

Once the EOP is implemented, the Chair of the Commission or the Chair's designee, as well as the Division Directors, will determine further action and communication.

Identification of Safety Personnel and Duties:


Safety Officer Duties:

- 1) Initiate emergency response action when notifications are received from the Capitol Police, National Weather Service, or other state, county or city authority.
- 2) Keep Floor Captains advised of all emergency information, including warnings and "all-clear" announcements by relaying information.
- 3) Maintain emergency communication equipment in his/her office.

Floor Captains and Trained Responder Duties:

- 1)
- 2) Assign person(s) to assist anyone who is physically disabled or injured.

3) Assist anyone who requires the use of a LifeSlider on the stairs.



Each Floor Captain is to notify the Trained Responders of the emergency. Trained Responders are to notify everyone in their vicinity.

MEDICAL EMERGENCY:

The employee who initially sees the medial emergency shall announce to the area there is a medical emergency on the floor and identify the Division or section.

All CPR trained employees are identified on Exhibit A,

If the subject is unconscious and not responding to their name, trained CPR employee shall designate someone to "Call 911" to request assistance and to "Grab the AED" from the bathroom corridor.

The individual who calls 911, or their designee, shall immediately go to the front desk and escort the emergency responders to the medical emergency location.

Any available employee trained in first aid should immediately go to the area and provide assistance. The Section Supervisor should go to the location and ensure all appropriate steps are taken and required notifications are made.

It is important all other employees not directly involved in providing or summoning assistance remain at their desks.

All accidents or medical emergencies must be reported to Human Resources (HR) Staff by filling out an 11-04 Injury Accident Report Form. The completed form should be given to HR within 10 days of the incident. The form can be found on the HR intranet site.



THREATENING WEATHER: Do NOT use the elevators / Close all doors, if possible

In case of severe weather or tornado warning, move far away from windows. When notified of severe weather, go to the first floor. See the floor emergency route maps in **Exhibit B**, safe rooms are shown in beige. Enter the designated safe rooms and close the door. If these are filled to capacity, use the first floor stairwells. Any employee unable to maneuver the stairs will be assisted down on a LifeSider by a Floor Captain or Trained Responder.

All employees must gather with their section so the Section Supervisor can make an accurate head count as soon as possible. The Supervisors shall notify the Safety Officer of any unaccounted for employee.

Alternate plan: If warning time is extremely short, you may not have time to take the stairs to the first floor areas. If your work area is on the **second floor**, close all doors and go to the areas designated in beige on the second floor map of **Exhibit B**. If your work area is on the **third floor**, close all doors and go to the areas designated in beige on the third floor, close all doors and go to the areas designated in beige on the third floor map of **Exhibit B**.

If you see threatening weather before receiving a warning, call the Safety Officer immediately.

Please, only one battery-operated radio per room.


POWER FAILURE:
