**MINUTES**

The motion was approved.

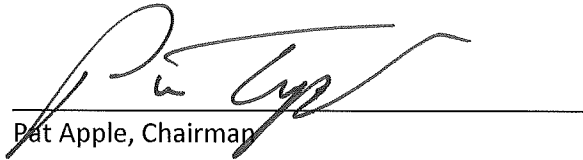
The Commission moved into Executive Session at 10:09 a.m. and reconvened in public session at 10:24 a.m.
