We charge these rates per truck per day and per man per hour for all of our activities, including packing, in transit, waiting, moving heavy/unusual items, and disassembling/reassembling. These are the maximum amounts charged to customers per month.

We add 15% to the labor charge on one or both ends if there is: a long carry (more than 50 feet from the truck); more than a 10 foot climb/descent from the truck; 20% more items to be moved than was listed; or the customer is not ready (still packing, residence is unacceptably dirty, cluttered or inaccessible; there is a hazardous item.
