### Regional Rate Comparisons-Based on Stakeholder Agreement

- Regional electricity rate comparison will be based on the following nine states, plus Kansas: Colorado, Missouri, Oklahoma, Arkansas, lowa, Minnesota, North Dakota, South Dakota, and Texas.
- All of the data will be sourced from the Energy Information Administration (EIA). Specifically, Tables 6, 7, and 8—released around October of every year for the previous year's data.
- The regional electricity rate comparison would consist of the following:
  - The average residential, industrial, and commercial electricity rate for each Investor Owned Utility (IOU) operating in these states, as reported by the EIA.
  - The average monthly electric bill for residential customers for each IOU operating in these states, as reported by the EIA.
  - The statewide average electricity rate for cooperative utilities in each of the states, presented for residential, commercial, and industrial customers as reported by the EIA.
  - The statewide average electricity rate for municipal utilities in each of the states, presented for residential, commercial, and industrial customers as reported by the EIA.
  - The statewide average electricity rate for all consumers across all utility types for each state.

### 2022 Update on Kansas Electric Rates

- In 2022, the most updated <u>annual</u> data we have from EIA, Average Electricity Rates in Kansas grew by 9.55% year-over-year.
- 2022 Electric Rates were heavily influenced by higher fuel prices in the aftermath of Winter Storm Uri and the Russian invasion into Ukraine.

- The fuel price inflation experienced in 2022 has largely abated in 2023, with average electricity prices falling 5.93% in Kansas during this time.





- Evergy's Monthly Bill data (from EIA) for residential customers shows that customer bills grew less than inflation until 2022, when fuel price inflation pushed Evergy rates and bills much higher.
- CPI increased by 29.27% during this same time frame.
- Evergy's preliminary bill data through October 2023 shows a 9.5% reduction for EKC compared to 2022--\$116.82. EKM preliminary data shows a 4.48% decline to \$128.08.

### Residential—

- Evergy Kansas Central (EKC) ranked 10<sup>th</sup> highest in rates, 14<sup>th</sup> highest in bills out of 38 utilities. Rates were 8.23% higher than average utility outside Kansas, Bills were 7.55% higher than average outside Kansas.
- Evergy Kansas Metro (EKM) ranked 11<sup>th</sup> highest in bills, 19<sup>th</sup> highest in rates out of 38 utilities. Rates were 0.52% lower, Bills were 11.66% higher than average outside Kansas.

### Commercial—

- EKC ranked 15<sup>th</sup> in rates, 4.51% higher than average outside Kansas.
- EKM ranks 24<sup>th</sup> in rates, -3.58% lower than average outside Kansas.

### Industrial—

- EKC ranked 19<sup>th</sup> in rates, 2.64% higher than average outside Kansas.
- EKM ranks 5<sup>th</sup> in rates, 22.09% higher than average outside Kansas.
