ACCESSORIAL CHARGES

Waiting Time: Same cost per hour as labor charges. Waiting time will begin as soon as team arrives at origin address.

Overnight Charge: \$155 per night to keep shipment on the truck

Packing & Material Charges: For current material rates, please refer to the Packing Materials Price List. Packing rates per hour are charged at the same rate as labor charges unless added as a promotion. Promotional add-on packing rate may be as low as \$35/hr/man.

Bulky Articles: For current rates, please refer to the Bulky Article Price List

VALUATION

Valuation is not insurance. If the customer does not release the valuation to 60 cents per pound on the Bill of Lading, valuation will revert to the Actual Cash Value option and the customer will be responsible for any additional coverage charges.

Actual Cash Value Protection

Under this option, Moving Proz LLC dba Moving Proz is liable for the actual cash (depreciated) value of lost, damaged, or destroyed goods in the entire shipment. If any article is lost, destroyed or damaged while in the Moving Proz LLC dba Moving Proz care, custody, and control, Moving Proz LLC dba Moving Proz will, at its discretion, offer to do one of the following for each item:

- Repair the item to the state in which it was prior to moving
- Replace with similar (like and kind) item
- Make a cash settlement

Actual cash valuation is calculated at \$30 per \$5000 in declared value. Customers are required to declare the value of their goods being transported. If a customer does not declare the value of their goods, then the customer's goods will be valued at \$6 per pound minimum. Moving Proz LLC dba Moving Proz maximum liability per truck is \$50,000.

Four deductibles: \$0, \$250, \$500, \$1000

Release Value (60 cents per pound)

Under this option, the Moving Proz LLC dba Moving Proz assumes liability for no more than 60 cents per pound, per article. Loss or damage claims are settled based on the pound weight of the article multiplied by 60 cents. The released value of \$0.60 per pound, per article is the minimal level of liability the Surface Transportation Board requires a carrier to offer the customer. This level of protection is available at no additional cost; however, it only provides minimal protections. To select this option the customer must specifically state this on the Bill of Lading. This means that claims are settled based on the weight of the individual article(s) multiplied by 60 cents. There is no additional cost for this minimal coverage.

If a customer's move involved items of extraordinary value (more than \$100 per pound), then the customer will be asked to disclose these items on the Bill of Lading within the Extraordinary Value Section.

Customer's Declaration of Value

On the Bill of Lading the customer will be asked to select one of the options below for valuation.

Option 1

Actual Cash Value Protection: if any article is lost, destroyed, or damaged while in your mover's custody, your mover will, at its option, either: (1) repair the article to the extent necessary to restore it to the same condition as when it was received by your mover, or pay you for the cost of such repairs; or (2) replace the article with an article of like kind and quality, or pay you for the cost of such replacement. Under Actual Cash Value Protection, if you do not declare a higher replacement value on this form prior to the time of shipment, the value of your goods will be deemed to be equal to \$6.00 multiplied by the weight (in pounds) of the shipment, subject to a minimum valuation for the shipment of \$6,000. Under this option, the cost of your move wide composed a base rate plus an added cost reflecting the cost of providing this actual cash value cargo liability protection for your shipment. If you wish to declare a higher value for your shipment than these default amounts you must indicate that value here. Declaring a higher value may increase the evaluation charge in your cost estimate.

Option 2

WAIVER of Actual Cash Value Protection: This lower level of protection is provided at no additional cost beyond the base rate; however, it provides only minimal protection that is considerably less than the average value of household goods. Under this option, a claim for any article that may be lost, destroyed, or damaged while in your mover’s custody will be settled based on weight of the individual article multiplied by 60 cents. For example, the settlement for an audio component valued at \$1,000 that weighs 10 pounds would be \$6.00 (10 pounds times 60 cents). Dollar Estimate of the cost of your move under the 60-cents option:

Prior Damage

Moving Proz LLC dba Moving Proz will not be liable for damages incurred prior to acceptance of goods or after delivery is made and the customer has had reasonable time to inspect the goods.

Prohibited Items

Moving Proz LLC dba Moving Proz will not transport the following items:

Hazardous items, flammables, explosive or dangerous articles, living things (plants, pets, etc.), perishable items

Tariff Adjustments

Moving Proz LLC dba Moving Proz will adjust the tariff as necessary with 30 days’ notice prior to implementation.

Assembly Services

Unless otherwise specified, the rates for loading and unloading include the disassembly and reassembly of furniture. Moving Proz LLC dba Moving Proz will only reassemble items that it disassembled at the load location. There are certain pieces of furniture that Moving Proz LLC dba Moving Proz will not disassemble and reassemble due to safety reasons.

Payment Method

Payment is due after completion of the unloading of the customer’s belongings. The only accepted forms of payment include: Visa, MasterCard, Discover, American Express, Discover, Cashier’s Check, Cash. Payment is due immediately upon completion of move. Carrier can accept cash deposit, but a card must be stored on file as well.

Impracticable Operations

If the mover is required to use specialized equipment and/or additional labor to complete pick up or delivery of the shipment, additional charges for services may be due. Full payment at the destination is required for these additional services and for 100 percent of the original binding estimate. An additional 15 percent will be due on delivery for impracticable operations.

Cancellations

For moves scheduled Monday -Thursday, this deposit is fully refundable as long as your move is cancelled or rescheduled before close of business (6pm) at least 5 days prior to your move date. For moves scheduled Friday - Sunday, this deposit is fully refundable as long as your move is cancelled or rescheduled before close of business (6pm) at least 7 days prior to your move date. Please send cancellation notice via phone call to 913-815-4044 Ext. 1 or send email to contact@movingproz.com There is no partial refund.

Moves that are scheduled on the same day as your move require the 2-hours minimum amount be paid up front as a deposit. Once your crew has been dispatched, this payment is non-refundable should you choose to cancel. Standard fee for cancellation is a loss of deposit payment.

Cancellation on the day of moving is a loss of deposit and potential charge for remaining job minimum.

Bulky Items-An additional mover may be added to the customers move if any of the following items are requested to be moved. Additional mover will be added at cost to the customer. For current rates please refer to the Bulky Article Price List.

Bulky / Unauthorized Items:

Definition: A Bulky Article is an item that requires special care and is not stackable. Bulky Article is also an item that is larger in its size than it is in its weight, therefore requiring more space to be used for its safety.

Items Moving Proz LLC dba Moving Proz will transport Hazardous materials such as:

JET SKIS, WIND SURFERS, CANOES, DINGHIES, KAYAKS, SCULLS, SKIFFS AND ROWBOATS less than 14 Ft. in length (over 14 Ft., see weight additives, below); when mounted on trailer, the bulky article charge will apply twice (i.e. once for each article named and once for each trailer);

LARGE SCREEN TV'S 40" and over (must be boxed), SATELLITE TV or RADIO RECEIVING DISCS/DISHES, including mounts, stands and accessorial equipment;

ORGANS, PIANOS AND HARPSICHORDS, any size;

PLAYHOUSES, DOLL HOUSES, TOOL SHEDS, UTILITY SHEDS, OR ANIMAL KENNELS or HOUSES, (Transported set-up, not dismantled, but limited to less than 7 Ft. height and 7 Ft. width);

and BATHTUBS, HOT TUBS, SPAS, WHIRLPOOL BATHS AND JACUZZIS, (measuring less than 65 cubic ft. in dimension) (transported set-up, not dismantled).

Claims/Complaint Process

The Department of Transportation requires household goods movers furnish to prospective individual shippers a written description of the customer complaint and inquiry handling procedure established and maintained by Moving Proz LLC dba Moving Proz At the time you make arrangements with your Moving Proz LLC dba Moving Proz representative, you should ask your representative for a description of the mover's procedure, information to contact the motor carrier, such as address, telephone number, etc. All communications with Moving Proz LLC dba Moving Proz shall be in writing to the claim representative listed below. We ask that you include your sales order number, move date, and shipment address with all correspondence.

Summary of Claim Procedure:

Shipper must notify Moving Proz LLC dba Moving Proz of cargo claims and file claims for cargo loss or damage within ten (10) days from the date of such loss, shortage or damage from the scheduled delivery date of the household goods. Shipper shall notify Moving Proz LLC dba Moving Proz within thirty (30) days of learning of claims other than cargo loss or damage claims and shall file any such claims at this time. Moving Proz LLC dba Moving Proz also offers neutral arbitration as a means of resolving consumer disputes involving ALL CLAIMS that arise from the transportation agreement between Shipper and Moving Proz LLC dba Moving Proz. Information setting out the neutral arbitration issues can be settled with the CSI Claim Services International 772-742-5246
