## Empire District Electric Company

**Docket No. 10-EPDE-314-RTS**

### Background

On November 4, 2009, Empire District Electric Company (Empire) filed an application with the Kansas Corporation Commission (KCC) requesting a rate increase of \$5.2 million.

The increase would involve all of Empire's approximately 10,102 retail customers in Kansas, of which 8,643 are residential, 1,229 are commercial and small industrial, 50 are large industrial, and 180 are public authority.

This includes the communities of Baxter Springs, Columbus, Galena, West Mineral, Roseland, Scammon, Treece, Weir, Camp 42, Carona, Hallowell, Lowell, Melrose, and Riverton in Cherokee and Labette Counties.

If approved, base rates would increase by 40% for all classes of customers. Beginning this summer, the average residential customer using 1,000 kilowatt hours would see their bill increase by \$25.08 a month.

Empire's last rate increase was in 2005, when the Commission approved a \$2.15 million (14%) increase. Since that time, Empire has invested in new generation (at Riverton, Iatan, and Plum Point), installed new pollution control equipment (at Iatan and Asbury), and seen an increase in annual operating costs.

### About the Commission

The KCC regulates public utilities including home telephone, natural gas, electric and water companies as well as motor carriers, oil and gas pipeline, and oil and gas producers. The KCC does not regulate most electric and water co-operatives, municipalities, wireless or long distance telephone service providers, cable companies, or the internet. The KCC's regulatory oversight of a public utility primarily pertains to rates and terms of service. In order to ensure that customers of regulated utilities are provided sufficient and efficient service at just and reasonable rates; utilities may not change their rates without KCC approval.
